DESCRIPTION OF REQUIREMENTS

REQUEST FOR EXPRESSION OF INTEREST

1. The United Nations Economic Commission for Africa seeks Expression of Interest (EOI) from duly registered companies for a site construction to house two (02) 150 KVA generator sets and power line wiring upgrade works at UNECA/SRO-CA in Yaounde, Cameroon.

More specifically, the project aims at:

- Building sites to accommodate 2 generators of 150 KVA each
- Constructing a firewall for the protection of generators
- Building a room to house the diesel tanks that will feed the generators
- Building a control room for the generators
- Supplying and installing of electrical cabinets including the general low voltage switchboard (TGBT)
- Installing 2 petrol tanks of 1500 liters each as well as the filling device and the diesel and electricity pipes for the generators
- Installing a lightning rod with a starting device
- Updating the electrical system of UNECA/SRO-CA as well as the installing all cabling and lighting systems
- Establishing a fire safety system for the generators and electrical cabinets, connected to the existing system at UNECA/SRO-CA.

2. Following this request for EOI a Request for proposal (RFP) including a detailed Scope of Work (SOW) will be issued to those companies who would express their interest.

3. Vendors wishing to participate in the solicitation exercises, at a minimum, must have completed the process of self registration at the Basic level in the UNGM portal, including confirmation of the acknowledgment of the United Nations Supplier Code of Conduct. However, Vendors are required to complete (upgrade) their registration to Level 1 before an award is issued.

4. Please note that this request for EOI is not an invitation for submission of proposal. UNECA reserves the right to reject EOIs received after the deadline indicated above.

SPECIFIC REQUIREMENT/ INFORMATION (IF ANY)

Interested vendors must also be able to provide a licence to show that they are authorized to operate in cameroon and should have an office in Yaounde.

Applicants who express their interest will participate in the subsequent Request fro Proposal process..
